4(d)	<p>AO2 12 marks</p> <p>Candidates must underpin their analysis and evaluation with knowledge and understanding. Candidates will be required to demonstrate thorough knowledge and understanding as well as accuracy of religion and belief when responding to the question and in meeting AO2 descriptors.</p> <p>AO2 Arguments for the statement</p> <ul style="list-style-type: none"> • Catholics have statues and sculptures that show the life of Christ, these can be used for reflection and quiet prayer. The visual aid will help them to focus and help to remind the faithful of important doctrines and saints • Catholics do not worship idols but the church used statues to visually portray the stories in the Bible. The stained glass windows in a church often depicted the stories from Jesus' life visually, so that everyone, including little children, could understand who Jesus was. Catholics use the statues of Jesus, Mary and the saints in our churches, to honour them and preserve their memory • The Catechism of the Catholic Church states that human art expresses humans relationship with God; that the creativity reflects God's gifts and powers which is given to humans. <p>Arguments against the statement</p> <ul style="list-style-type: none"> • Some people claim statues and sculptures encourage idol worship which is in clear violation of the second Commandment • many of the statues and sculptures are inaccurate; the majority of the statues of Jesus have no resemblance to the way He actually looked.
